1656 TO DISCUSS BIKE SHELTERS

The Clerk informed Cllrs that East Riding Council had asked the Parish Council to suggest a location for a possible bike shelter.

Councillors discuss locations and agreed on The Parkway shops.

1657 TO DISCUSS PEDESTRIAN SAFETY AND SPEEDING

Cllr Cantrell raised concerns regarding speeding and lack of signage on Dunswell Road and the danger it was causing to school children and wildlife.

Cllr Duke stated that he believed George Street and Finkle Street should be 20mph zones.

Cllrs discussed the potential for the whole of the village to be a 20mph zone and agreed it warranted further investigation.

1658 TO DISCUSS STREET LIGHTING

Cllr Abel informed Cllrs that she had contacted East Riding Council regarding the installation of a light in the alley between Millhouse Woods Lane and Linden Avenue but had been informed that it would be prohibitively expensive as cabling would be required.

Cllr Casson stated that further crimes had been committed in the area and local residents were certain that a light had been present in the past. He asked if full pricing could be given.
