1942.2 Clerk Pape reported that the East Riding Council Planning department had advised that the appeal submitted regarding Planning Application 24/00003/REFUSE (Erection of railings on existing wall to property boundary to highway and installation of electric sliding gate to driveway entrance - 285 New Village Road, Cottingham) had been dismissed.

1942.4 Clerk Pape reported that Lianne Darbinson, East Riding Council Traffic Management Senior Engineer, had checked speed data for George Street; whilst the average day time speed was 18mph there were higher speeds occurring between midnight and 4am – this increasing the all day 85th percentile to 26.68mph. East Riding Council had offered to include George Street within their next batch of speed surveys – Cllrs accepted this offer.

Resolved: that the Parish Office contact East Riding Council to accept the offer for George Street to be included in the next batch of speed surveys.
