1983 TO DISCUSS CONSULTATION ON SUGGESTIONS FOR CHANGES TO RESTRICTIVE BARRIERS IN SNICKETS TO IMPROVE WHEELCHAIR AND MOBILITY SCOOTER ACCESS

1983.1 The Clerk reported that East Riding of Yorkshire Council had been asked to consider the removal of, or alteration to, some barriers in snickets around Cottingham, such as railings and bollards, which appear to be causing access restrictions for wheelchair or mobility scooter users. These may be at entrances to alleyways, parks or other snickets.

Recommendations for changes have been submitted by the East Riding and Kingston Upon Hull Joint Local Access Forum (JLAF), they are aimed at improving equality of access for all residents, including wheelchair users, mobility scooters and other groups requiring enhanced accessibility, in line with current legislation and guidelines for best practice.

East Riding of Yorkshire Council is considering the requested changes and had invited the input of the Parish Council on this matter.

Cllrs discussed the consultation and supported the proposals of the East Riding and Kingston Upon Hull Joint Local Access Forum (JLAF) along with the additional comments made by ERYC, the office will complete the spreadsheet and forward to ERYC
